She is also working on the PHACS CAB webpage. It will be part of the larger PHACS website. It will contain:

# CAB SURVEY AND FUTURE DISCUSSION ITEMS

**Tanisha Savage** thanked members for their survey responses. The PHACS leaders will better understand local CAB activities with this information. The survey results were reviewed. Most CABs include clinical site staff, study participants, their family members and community members. Some sites said their PI or co-PIs attend CAB meetings. Most CAB meetings have a formal agenda. The survey results showed that CABs tend to meet monthly or quarterly. The issues discussed include:

- The research process and the CAB role;
- Community value and input to the CAB;
- Research goals and who benefits;
- Research impact on treatment services;
- Confusion and controversy surrounding human research; and
- Disclosure and stigma.

On future CAB calls, the group would like to discuss:

- Quality of life issues (for example, medications, nutrition, lipodystrophy);
- Disclosure and stigma; and
- Resources, especially for adolescents.
