PHACS CAB EVALUATION SURVEY RESULTS

INVITATION FROM THE PULMONARY COMPLICATIONS IN PHACS AMP (PCPA) PROTOCOL TEAM

Julie from Westat talked about the Pulmonary Complications in PHACS AMP (PCPA) protocol. The PCPA study will be looking at lung diseases in the PHACS AMP cohort. Participants will be currently enrolled AMP participants. The protocol team is looking for signs of lung abnormalities of structure and function. Participants will be given a survey about asthma history, degree of asthma, and control and history of exposure to tobacco. Participants will go answer questions, have some blood tests, and other tests to see if participants have sings of lung disease. One objective of the study is to estimate

and compare the prevalence of lung disease in HIV-infected and HIV-exposed but uninfected children. The other objective is to explore the link between lung disease and immune dysfunction.

A CAB representative was invited to join the PCPA protocol team. The CAB representative has to attend conference calls. The CAB representative should give feedback on the protocol. The next PCPA protocol team call is Wednesday, October 31 at 9:00 AM EST. Delia and Sherry volunteered to be on the PCPA protocol team.
