# • BRAINSTORM: WOMEN'S HEALTH QUESTIONS FOR RESEARCHERS

**Mandy** explained that during the CAB Retreat at the PHACS network meeting there will be a Researcher open discussion. During the session, Deb Kacanek and Kate Powis will talk about women's health research. Mandy asked CAB members which questions they would like to address during the open discussion.

CAB members suggestions:

- **Rosalva** suggested research on aging with women living with HIV, focusing on long term effects of ARVs.
- **Kim** mentioned that the Women's Health Working Group are proposing research on the three stages of menopause (perimenopause, menopause, and postmenopausal). During the HOPE September call, there will be a presentation on menopause.

- **Tameka** suggested research on the effects of ARVs in long term use with respect to hormones, sleep deprivation, and weight. She mentioned menstruation as another topic.
- Chitara mentioned research on the pelvic floor.
  - **Claire** indicated that in the report that was sent to the NIH in December 2023 this topic was included as women's health priorities.
- **Kim** shared that there is no research on the optical health of women living with HIV.
- Chitara would like updates on the HPV study.
  - **Claire** explained that the HPV study is looking at how effective is the HPV vaccine in women living with HIV.
- CAB members had a discussion on disclosure. Themes that were discussed included:
  - Site staff support
  - How to deal with and overcome stigma
  - Disclosure to family members
  - Education on HIV
  - How a person prepares if they decide to disclose
  - Understanding that every person's journey is different.
  - Claire shared the HECC's "Caregiver Guide to Disclosure Decisions": <u>https://phacsstudy.org/cms\_uploads/Health%20Education%20and%20Communication</u> <u>%20Documents/Caregiver\_Guide.pdf</u>
    - Guide was created with guidance/wisdom from caregivers living with HIV talking about factors that influence their decision either way.
