• APPROVAL OF MINUTES

• UPCOMING PRESENTATION TO INTERDISCIPLINARY ASSOCIATION FOR POPULATION HEALTH SCIENCES

Claire explained that <u>Tiffany Lemon</u>, assistant professor at the College of Health Solutions, invited the community members to a seminar. The seminar is hosted by the Interdisciplinary Association for Population Health Sciences (<u>IAPHS</u>). It is focused on community engagement and participation. Tiffany invited the community members because of their expertise and experience. She indicated that the audience (researchers, practitioners, and students) would benefit from learning about the community-inclusive research in PHACS. **Claire** mentioned that the audience is doing quantitative research, not necessarily focused on HIV. The idea is to explain and promote the community engagement model in PHACS. Also, to present on the importance of study participants' experiences in shaping research.

• PHACS SPRING NETWORK MEETING UPDATES

Mandy explained that PHACS leadership is having conversations if the meeting should be switched to virtual. Sites have expressed concern on the financial stress due to the closure of the PHACS P01 grant, which would make travel to the meeting difficult. **Mandy** mentioned that when leadership have a final decision, it will be communicated with the community members.
